



## **OJP Bureaus and Offices**

- Bureau of Justice Statistics (BJS): Collects, analyzes, publishes, and disseminates statistical information on crime, criminal offenders, victims of crime, and the operation of justice systems at all levels of government. - http://www.bjs.gov/
- National Institute of Justice (NIJ): Focuses on research, development, and evaluation; forensic laboratory enhancement; and research fellowships. - http://www.nij.gov/
- Office for Victims of Crime (OVC): Provides leadership and funding on behalf of crime victims; administers the Crime Victims Fund established under the 1984 Victims of Crime Act (VOCA) to help victims and victim service providers with program funding *http://ojp.gov/ovc/*
- Office of Juvenile Justice and Delinquency (OJJDP): Implements effective programs for juveniles; gangs; juvenile reentry; Internet crimes against children; tribal youth, etc. http://www.ojjdp.gov/
- Office of Sex Offender Sentencing, Monitoring, Apprehending, Registering, and Tracking (SMART): Administration, training, and technical assistance related to the national implementation of comprehensive Sex Offender Registration and Notification (SORNA) Program set forth by the Adam Walsh Act; protection of children and others from sexual abuse or exploitation, etc. - http://www.smart.gov/

- Community Oriented Policing Services (COPS): Awards competitive, discretionary grants directly to law enforcement agencies across the U.S. and its territories, including community policing http://www.cops.usdoj.gov/

## **Bureau of Justice Assistance**


BJA provides leadership and services in grant administration and criminal justice policy development to support local, state, and tribal justice strategies to achieve safer communities.

#### **BJA's Guiding Principle Statement:**

## Reduce crime, recidivism, and unnecessary confinement, and promote a safe and fair criminal justice system.

**BJA Strategic Focus Areas:** 

- 1. Reduction of violent crime, improvement of community safety, and support for public safety officers.
- 2. Reduction of recidivism and prevention of unnecessary confinement.
- 3. Integration of evidence-based, research-driven strategies into the day-to-day operations of BJA and the programs BJA administers and supports.
- 4. Increasing program effectiveness with a renewed emphasis on data analysis, information sharing, and performance management.
- 5. Ensuring organizational excellence.





### Public Safety Officers' Benefits Program

- The PSOB program serves the broader public safety community- law enforcement, firefighter, and other first responder survivors and disabled public safety officers.
- PSOB provides no-cost support to public safety agencies including training and technical assistance in responding to line-of-duty deaths.
- Tools and checklists are available to assist agencies and survivors with submitting claims.
- PSOB Benefits include: Death, Disability and Education



### Edward Byrne Memorial Justice Assistance Grant (JAG) Overview

- JAG is OJP's flagship grant program and the leading source of federal justice funding to state, local, and tribal jurisdictions.
- JAG funds may be used across seven broad purpose areas:
  - Law enforcement
  - Prosecution and court
  - Crime prevention and education
  - Corrections and community corrections
  - Drug treatment and enforcement
  - Planning, evaluation, and technology improvement
  - Crime victim and witness programs (other than compensation)
- Allowable costs include training, personnel, equipment, supplies, and contractual support.

- Results that add to the body of knowledge about what works in criminal justice



# **Body Worn Cameras (BWC)**

- In FY 2015, BJA launched the BWC Policy and Implementation Solicitation Program. This program supports the implementation of BWC programs in law enforcement agencies across the country.
- The intent of the program is to help develop, implement, and evaluate a BWC program as one tool in a law enforcement comprehensive problemsolving approach to enhance officer interactions with the public and build community trust.
  - In FY 2015, BJA made 74 awards (73 = To Localities; 1 Award = TTA Provider), totaling \$21.3M.
  - > 55,000 BWCs were requested, and 21,000 were awarded.
- In addition to the resources listed below, BJA's JAG Program is a valuable resource for agencies when seeking funds to implement BWC Programs.



## **Sexual Assault Kit Initiative**

- In FY 2015, BJA launched its Sexual Assault Kit Initiative (SAKI) in response to kits that have never been submitted to a crime laboratory.
- The goal of the SAKI is the creation of a coordinated community response that ensures just resolution to these cases whenever possible through a victim-centered approach, as well as to build jurisdictions' capacity to prevent the development of conditions that lead to high numbers of unsubmitted SAKs in the future.
- In FY 2015, BJA made 21 awards totaling \$30.3M, and also made 1 TTA award totaling \$6.0M.



### National Training and Technical Assistance Center (BJA NTTAC)

- BJA NTTAC's TTA services cover a broad set of topic areas and are delivered through training, information dissemination, technical assistance, curriculum development, data analysis, onsite and distance learning, peer-to-peer visits, research and information requests, and strategic planning assistance.
- BJA NTTAC has committed a limited amount of resources to support TTA engagements in four priority areas:
  - Enhancing the work of community corrections agencies;
  - Enhancing the capabilities of crime analysis and law enforcement personnel to analyze and use data to make informed decisions and respond effectively and prevent crime;
  - Assist communities in preventing and deterring crime using the Crime Prevention through Environment Design (CTED) approach; and
  - Offering training for law enforcement personnel.
