




Federal Stimulus - Primary Recipients





American Rescue Plan Financial Summary All data as of 9/26/22


Total Statewide Award by Grant Group





American Rescue Plan Portfolio Summary


Count of Grants by Grant Group












COVID-19 Vaccinations Percentage SLFRF Expenditure Group 1 Outcome Measure


Percent of Total Population that Has Received at Least One COVID-19 Vaccine Dose by Race/Ethnicity, as of July 11, 2022











SHIP Prenatal Care Rate (First Trimester Care) by Race / Ethnicity, Statewide






